



Subject: Information provided pursuant to art. 13 of EU Regulation 2016/679 (hereinafter, for the sake of brevity, the "GDPR")

1. Data Controller

The data controller is B2Green with registered office in MILAN (MI) VIA ALESSANDRO TADINO 19CAP 20124, VAT number 11590240963, email address info@b2green.it.

The Data Controller decides independently on the purposes and methods of processing, as well as on the security procedures to be applied to ensure the confidentiality, integrity and availability of data.

2. Legal basis and purpose of the processing

The processing of your personal data (hereinafter, the "Data") will take place following the completion of the form by you in order to request information regarding the services provided by B2Green in order to provide a response to your request.

The legal basis of the data processing lies in your consent to the processing of the data.

The provision of data is optional, but failure to provide the same will not allow the use of the contact service with the owner.

The data processing carried out by the Data Controller does not provide for any automated decision-making process.

The processing of the data of which you are interested will be based on principles of correctness, lawfulness, transparency and will take place both in paper form and with the aid of electronic tools, in a lawful manner and in compliance with the rules of confidentiality and security and of the Data Controller's Privacy Policy made available on the Website.

3. Processing methods

Data processing is carried out mainly electronically by B2Green and by other subjects who, appropriately selected in terms of reliability and competence, carry out operations that are instrumental to the pursuit of the owner's corporate purpose.

4. Scope of communication of the Data

The employees and / or collaborators of the Data Controller in charge of managing the Data may become aware of the Data. These subjects, who have been instructed to do so by the Data Controller pursuant to art.

29 GDPR, will process the Data exclusively for the purposes indicated in this statement and in compliance with the provisions of the applicable legislation.

Furthermore, third parties may become aware of the Data who may process the Data on behalf of the Data Controller as external data processors, such as, by way of example, IT and logistics service providers, outsourcing or cloud computing service providers, professionals and consultants.

The Data will not be disclosed to third parties, except in cases where the communication is mandatory by law or is necessary for purposes provided for by law for the pursuit of which the consent of the interested party is not required; in such cases, the Data may be made available to third parties who will process them independently and solely for the aforementioned purposes (for example, in the event of requests made by the police or the judiciary or other competent bodies).

5. Duration of treatment

Your data will be kept for a maximum duration of 24 months from the date of sending the form by you (without prejudice to the right of revocation and opposition as indicated in the following article 8).

6. Data Transfer

The Data may be processed both inside and outside the European Economic Area in compliance with the rights and guarantees provided for by current legislation, it being understood that any transfer of data outside the European Economic Area will take place in the presence of the conditions of adequacy of the country of transfer or in any case subject to the signing of agreements containing adequate contractual standards containing clauses approved by the European Commission for the protection of data.

7. Data Security

Specific security measures are observed by B2Green to prevent, in addition to unauthorized access, also their loss and illicit or incorrect use.

8. User rights You have

the right to:

- ask the Data Controller to access the Data, update, correct or delete them or limit their processing or to oppose their processing;
- in relation to the treatment based on the legal basis of consent, to withdraw your consent at any time, without prejudice to the lawfulness of the treatment based on the consent given before the revocation;
- propose a complaint to the National Supervisory Authority;
- receive in a structured format, commonly used and readable by an automatic device, the personal data you have provided for portability purposes.
